Clean Corridor Congress #2: Filling the Infrastructure Gap

Two years ago, the NEDC held its first Clean Corridor Congress at the 2015 NEDC meeting in Providence, RI to engage partners, technologies and strategies to visualize clean freight corridors in the Northeast. As an outcome, the NEDC created the Northeast Clean Freight Corridors (NECF) Workgroup to coordinate across states, sectors, and disciplines to promote the development of clean corridors in the region. With 13 NECFC webinars, three FHWA Alternative Fuel Corridor designations, and the successful November 2016 Clean Corridors Meeting in Troy NY under our belt, we have made great progress in understanding the challenges and opportunities for implementing clean corridors. Now, how do we fill in the infrastructure gap?
